



# Conditions of Use ParcAlpin

(Version May 2025)

These Conditions of Use must be read and signed as understood and accepted before entering the ParcAlpin. This also includes supervising adults of children under the age of 15. Users confirm that they understand and accept the conditions of use and will observe them by signing the application form.

1. Insurance is the responsibility of the user. ParcAlpine rejects all liability.
2. The use of ParcAlpine is at your own risk and responsibility. Adult accompanying persons are responsible for children under the age of 15. Parc Alpine accepts no liability for damages. The foregoing particularly applies to falling branches or similar.
3. The park is not supervised. The sole function of park staff is to provide instruction, monitoring and assistance.
4. Before using the park, users must participate in the entire theoretical and practical safety instruction. The user must raise and clarify any points that are unclear during instruction. All instructions and decisions of ParcAlpine employees are binding. Offences or infringements of safety requirements may lead to a user being excluded. In this case, there is no entitlement to any refund of the admission price.
  - a. Minimum age/minimum height per course.
    - **Marmot:** The minimum age is 4 years. The children must be supervised by an adult person.
    - **Deer:** The minimum age is 6 years. Children from 6 to 8 years must be accompanied by an adult person. Children from 8 to 11 years must be supervised by an adult person.
    - **Spider:** The minimum age is 6 years. Children from 6 to 8 years must be accompanied by an adult person. Children from 8 to 11 years must be supervised by an adult person.
    - **Chamois:** The minimum age is 8 years. Children from 8 to 10 years must be accompanied by an adult person. Children from 10 to 14 years must be supervised by an adult person.
    - **Bearded vulture:** The minimum height is 125 cm (49 inches), the minimum age is 8 years. Children from 8 to 10 years must be accompanied by an adult person. Children from 10 to 14 years must be supervised by an adult person.
    - **ibex:** The minimum age is 10 years. Children from 10 to 11 years must be accompanied by an adult person. Children from 11 to 14 years must be supervised by an adult person.
  - b. The permitted maximum weight per user is 30 kg (88 lb) for the Marmot Course and 100 kg (220 lb) for all other courses.
  - c. The safety karabiners must always clip onto the orange safety wires. While changing, there is always only one belaying karabiner which can be detached from the safety rope. Changing requires at all times one karabiner being clipped.
  - d. Each element may only be used by one person at the time. On any platform, there is a maximum of three people at the same time permitted.
5. Using the park is not advised to pregnant women.
6. Persons under the influence of alcohol, drugs or strong medication are not permitted to use the park.
7. The user acknowledges that small mechanical injuries such as skin abrasion may occur. Moreover, dirt such as resin or other is possible.
8. There is no entitlement to any refund of the admission price should staff be forced to close the ParcAlpine through force majeure such as storms or tempests.
9. The place of jurisdiction is Sent. Swiss law is exclusively applicable.
